ABOUT THE LL.M. PROGRAMME:

The objective of introduction of LL.M. One Year Programme is to develop the professional persona of aspirants of LL.M. Program with the combination of learning the Law with practical approach. This budding University aims to use interdisciplinary approach to legal studies with dynamic and flexible curriculum taught by experienced and qualified faculty.

ABOUT THE ADMISSION

Admission to *Master of Law* (LL.M.) (one year programme) in Dr. Bhimrao Ambedkar Law University, Jaipur, shall strictly be made on Merit basis for the Session 2022-23.

DURATION 01 Year (Two Semesters)

ELIGIBILITY FOR ADMISSION

THE TERM UNIVERSITY WHEREVER MENTIONED IN THIS DOCUMENT MEANS AND DENOTES HEREINAFTER 'THE STATE FUNDED UNIVERSITIES OF RAJASTHAN'.

A Candidate who has passed the Bachelor of Laws (P) degree Examination of the University or an examination of some other University recognized by the Syndicate as equivalent there to securing minimum of 55% marks in the aggregate or a candidate who holds LL.B.(P) Three Year / Five Year degree and has also passed any of the Diploma courses of the university in the Faculty of Law with 55% marks in the aggregate at the Diploma Examination (i.e. having law degree) and thereafter pursued

a regular course of study in an affiliated colleges for one academic year shall be eligible for admission to L.L.M. Part I Examination.

The candidate must possess a Bachelor degree in Law (P) / PG diploma as specified above with minimum of 55% marks in aggregate for UR and EWS and (50% for SC, ST, OBC, MBC & Divyang).

• UR: Unreserved Category, SC - Scheduled Caste, ST - Scheduled Tribe

• OBC: Other Backward Class, MBC: Most Backward Class

• Divyang: PWD

ADMISSION CRITERIA

In view of the pandemic crisis, the university took into consideration the limitations in conducting Entrance Test for admission in LL.M. programme Therefore, it has been decided that the admission may be done on the basis of Merit of the student in qualifying examination. i.e. Bachelor's Degree in Law or PG Law Diploma Examination. The percentage claimed by the candidate at the time of filling of his/her Online application form shall only be considered as final for preparing the merit list of the admission and no other document in this regard shall be entertained by the University afterwards.

The online application form may be edited by the candidate till the last date of the filling of the Online Application form.

Intake and Reservation:

• Intake: 60 (Sixty) Seats

• Reservation: As per rules and policy of the State Government.

STEPWISE PROCEDURE FOR APPLICATION

STEP-I

1. The Candidate is required to fill the Application Form for Admission to LL.M. One Year Semester Course at https://admission.alujaipur.ac.in and complete the registration which will commence from June 22, 2022.

STEP-II

- 1. After completing personal details, the candidate is required to submit the requisite application fee i.e. Rs. 1200/- for all categories, online through payment gateway.
- 2. No other mode for payment of fee shall be accepted.

STEP-III

1. After successful submission of fee the candidate is required to upload his/her photograph, signature, Mark sheets of class X & XII and Bachelor's Degree in Law or PG Law Diploma Examination (original/online), category certificate (if applicable) and P.H. Certificate (if applicable):

a) Photo Requirement:

- The photograph must be taken on or after 01 January, 2022.
- Don't wear a cap, mask or goggles while getting the photograph clicked.

 Candidates who wear spectacles regularly can put them on.
- Computer and Polaroid generated photographs will not be accepted.
- Image Size: upto 200 KB
- Acceptable file formats- JPG/GIF/BMP/PNG

Note:

- If the scanned photographs do not meet the above-mentioned criteria, the form will be rejected.
- If the photographs are found to be manipulated or digitally edited, the form will be rejected. This would be considered as use of unfair practices and would be dealt with according to the rules of unfair means.

b) Signature Requirement:

- Image size: upto 200 KB
- Acceptable file formats JPG/GIF/BMP/PNG

c) Documents Required:

- Upload your Mark Sheets of Class X & XII and Bachelor's Degree in Law or PG Law Diploma Examination. (Original or online)
- Upload Latest Caste Category Certificate, wherever applicable, as per State Govt. Rules.
- Upload Divyang (PWD) Certificate, if applicable.

STEP-IV

- 1. The applicants are not required to deposit the hard copy of the online application form. However, they are advised to take the print of the invoice and the complete application form along with all original documents and their photocopies and for own reference.
- 2. The hard copy of application form and related original documents are to be submitted as on date of counselling/document verification.

Note:

The candidates are advised to check and verify the application form before submission. The percentage claimed by the candidate at the time of filling of his/her Online application form shall only be considered as final for preparing the merit list of the admission and no other document in this regard shall be entertained by the University afterwards.

The online application form may be edited by the candidate till the last date of the filling of the Online Application form.

INFORMATION REGARDING THE ADMISSION TO LL.M. (ONE YEAR PROGRAMME)

- 1. There are 60 seats in Dr. Bhimrao Ambedkar Law University, Jaipur for LL.M. (one year programme).
- 2. Admission to the LL.M. (one year programme) shall be on the basis of Merit of marks secured in eligibility degree i.e. Bachelor's Degree in Law or PG Law Diploma Examination.
- 3. Final Merit List shall be declared after counseling and document verification.
- 4. In case where two or more candidates stand on same Merit Position, preference shall be given to the candidate on the following criteria (in descending order):
 - a) Who has secured higher marks in Class XII;
 - b) Who is older than other in age;
- 5. Applicants who have appeared in their eligibility degree are allowed to fill up the application form but applicant must have his/her marksheet of eligibility degree on the last date of submission of online application form. He/she will also be allowed to enter his/her marks & percentage of eligibility of the last date of submission of application form.
